**Houston County Middle School 9:00 am Saturday, March 17, 2012**

**PARADE RULES:-** These rules are designed for the safety of all involved. Please read & follow them closely.

1. Only the vehicle pulling a float entry or other parade entries will be allowed into the Parade Line-up area. Unauthorized vehicles will be turned away. **Please have candy or decoration in the vehicle. Please have adequate gas in the vehicle before lining up.**
2. Parade entries may not change their location in the Parade Line-Up. Decorating must be complete by the start of the parade.
3. The Chamber will not be responsible for entries left unattended at the line-up site.
4. Adults **MUST** be present on any entry carrying minor children. **NO ONE** under the age of 21 will be allowed to walk beside or near any float or vehicle.
5. Silly String is not permitted and will be confiscated.
6. Participants may not exit their float or vehicle while the parade is in motion. In addition, no one is allowed to ride or stand on running boards or ride on fenders or hoods of cars/trucks.
7. Horses, mules, donkeys may be used to pull wagons, carriages, or buggies. **NO** other horses, mules or donkeys will be allowed. No single rider horses allowed.
8. **NO Pets** allowed.
9. Drivers **MUST** be 21 and drivers are **NOT** allowed to throw candy.
10. **NO Minors** will be allowed to throw candy or other objects from the vehicles or floats.
11. A copy of **PROOF OF INSURANCE MUST** be attached to this form to enter the Parade.
12. By signing below participants accept full responsibility for all occupants of their float or vehicle and does hereby release The Houston County Area Chamber of Commerce & the City of Erin, its employees and or agents from any and all liability resulting from damage or injury to the participant or their occupants in this event.

**ENTRY FEE: \$25** (make checks payable to Houston County Area Chamber of Commerce)  
Fees are due for individual entries, pageant winners or companies advertising a business or event or those seeking an elected office. **Parade entry fee and proof of insurance must accompany this form.**
